IMPORTANT INFORMATIONS TO THE APPLICANTS WHO HAVE APPLIED FOR THE POST OF REGISTRAR

• The University had advertised the post of Registrar vide Advt. No. 003/2013 dated 24th September, 2013 to be filled by Direct Appointment or on Deputation for a period of five years or attaining the age of 62 years, whichever is earlier. The essential and desirable qualifications prescribed for the said post are reproduced as under:

Essential Qualifications:

- i. Master's Degree with at least 55% of the marks or its equivalent grade of 'B' in the UGC seven-point scale.
- ii. At least 15 years' of experience as Assistant Professor in AGP of Rs. 7000 and above or with 8 years' of service in the AGP of Rs. 8000 and above including as Associate Professor along with the experience in educational administration.

OR

Comparable experience in research establishment and / or other institutions of higher education.

OR

15 years of administrative experience, of which 8 years shall be as Deputy Registrar or an equivalent post.

Desirable:

- I. Ph.D. in any subject from a reputed institution.
- II. Experience of administrative practices, human resource management, statutory functions and academic activities of Universities / R&D institutions.
- III. Experience of handling legal matters.
- IV. Experience of IT applications in administrative matters.
- In response to said advertisement, the University had received total **66 applications** for the post of Registrar.

- The Screening Committee met on 27th February, 2014 and scrutinised all applications received in accordance with the qualifications, terms & conditions given in the Advt. No. 002/2013 dated 24.09.2013. After scrutinising, the candidates given in LIST 'A' (Page No. 3 to 5) were found eligible to be called for Interview as they meet the minimum qualifications and eligibility conditions. The candidates given in LIST 'B' (Page No. 6 to 9)were found to be non-eligible as they do not meet the minimum qualifications and eligibility conditions.
