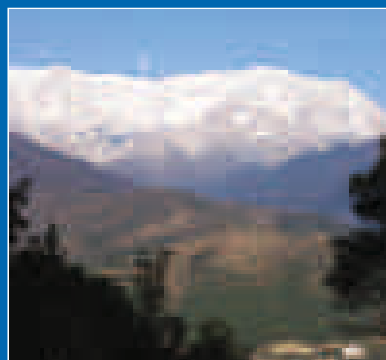
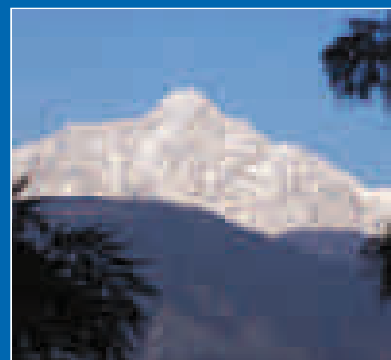

## VICE-CHANCELLOR'S MESSAGE

I am happy to present the Annual Report of the University for the year 2010-11 with great deal of satisfaction. It was indeed a year of great challenge and ample opportunities. The Central University of Himachal Pradesh (CUHP) became functional with the assumption of charge by the first Vice-Chancellor on 20th January 2010. In a short-span, the University has made significant progress. The University has already developed its Vision Document & Strategic Plan. The academic architecture and curricular framework have been developed and are being translated into action through Statutes and Ordinances.



The land for the campuses of the University have already been identified but it may still take time before the same are transferred to the University, since it requires obtaining clearance under the Forest Conservation Act and also from the Environmental angles. Notwithstanding the constraint, the University commenced its operation and administrative activities were started from the Camp Office which was set up in the building called Writers' Home (Sanskriti Sadan) in Dharamshala. The Academic activities of the University were launched from its Temporary Academic Block - a newly constructed building of a Government College that was graciously allotted by the State Government to the University. The Temporary Academic Block is located in Shahpur at a distance of approximately 30 Kms from the Camp Office. Despite limitations of intellectual and human resources, the University focused its attention to the drafting of necessary Statutes, Ordinances and Bye-laws. Within a few months of its existence, the University was able to launch its academic programmes and published its Prospectus. The Budget, Annual Accounts and Balance Sheets for the years 2009-10 were prepared on priority and got audited by the CAG, in accordance with the requirements of the Act and Statutes.

The University embarked upon innovative curricular framework based on modular courses, admission based on single common entrance examination, semester system, continuous internal assessment, grading system, choice based credit system and grading. The curricular framework of the University is comparable to the best practices found in some of the best universities of the world. It is our belief that it was the innovative academic architecture and innovative curricular framework that attracted overwhelming response from the potential students and in the very first year of the launch of the academic programmes, a large number of applicants applied for admission and took the Entrance Examination.

The University initially began its operation with thirteen core staff sanctioned by the UGC. Such staff were taken either on deputation or on short-term contract basis. Gradually, the University was able to advertise, process and fill up the statutory positions of the Registrar and the Finance Officer. To run the University at initial stage, the University Grants Commission provided a few posts. The University created 48 teaching positions and a similar number of non-teaching positions with the concurrence of the University Grants Commission. Efforts are on to appoint the best available people to these position - a challenge not easy to surmount.

The University received all the support and facilitation from all the officers and staff of the University Grants Commission and the Ministry of Human Resource Development, but for which the progress would have been seriously constrained. I am equally thankful to the State Leadership and District Administration at Dharamshala and Dehra, for their help and support in the identification of land for the campuses of the University and for allotting the buildings for the camp office and also for the temporary academic block. But for the whole hearted cooperation of the Chief Minister, the Education Minister, the Chief Secretary, the Principal



Secretary Education and the DC and other District Officials, the University would not have made the kind of strides that it was able to.

I would like to place on record my appreciation and thanks to my smaller team of three officers viz. Prof. Yoginder Verma, Prof. Arvind Agrawal and Shri B.R. Dhiman, who contributed their might by taking many responsibilities right from the initial stages and shared serious hardships. Assistance rendered by Mr. Vivek Sood, the Liaison Officer to the Vice-Chancellor were remarkable. I also acknowledge the efforts of all officers and staff of the University and hope that each one of those associated with the University shall continue to contribute towards the development of this University.

In a country like ours that has a long and cherished history of higher education and has many large and well established universities and institutions of national importance, we have made a humble beginning. We are just in our infancy and are fully aware of the challenges that lie ahead. What gives me hope and confidence is the realisation that I know no man who was not a child before and I know no tree that was not a sapling once. The sapling has been planted and due care are being taken to nurture and protect it from the vagaries of all kind of weathers and I hope that the soil would be conducive to its growth.

## ABOUT THE UNIVERSITY



### GENESIS AND ESTABLISHMENT OF THE UNIVERSITY:

The Prime Minister in his address to the nation on August 15, 2007, announced the establishment of a Central University in each of the states that which so far did not have a central university. Subsequently, the Central Universities Act 2009 (No. 25 of 2009) which received Presidential assent on 20th March 2009 was enacted to establish these Universities and it was under this legislation that the Central University of Himachal Pradesh was established and came into existence in 2009.

### COMENCEMENT OF OPERATION:

The University became functional with the assumption of charge by the first Vice-Chancellor on 20th January 2010. While development of own infrastructure of the University may take a while, the University has an ambitious Vision Document evolved in consultation with eminent experts in the field of education. The Vision Document and Strategic Plan of the University as approved by the statutory authorities of the University are available at the website of the University ([www.cuhimachal.ac.in](http://www.cuhimachal.ac.in)). Accordingly, in due course of time, the University will grow to have purpose built, state of the art 150 Acres campus in Dharamshala and 900 Acres campus in Dehra and will have seventeen Schools of Studies with nearly 90 Departments of Studies and about 50 Centres of Studies.

### OBJECTIVES OF THE UNIVERSITY:

The Objectives of the University as given in the Central Universities Act 2009 are as under:

- ◆ To disseminate and advance knowledge by providing instructional and research facilities in such branches of learning as it may deem fit;
- ◆ To make special provisions for integrated courses in humanities, social sciences, sciences and technology in its educational programmes;
- ◆ To take appropriate measures for promoting innovations in teaching-learning process and inter-disciplinary studies and research;
- ◆ To educate and train manpower for the development of the country;
- ◆ To establish linkages with industries for the promotion of science and technology;
- ◆ To pay special attention to the improvement of social and economic conditions and welfare of the people, their intellectual, academic and cultural development

### SALIENT FEATURES OF THE UNIVERSITY:

The Central Universities Act 2009 mandates the following salient features of the University:

- ◆ The University shall be open to persons of either sex and of whatever caste, creed, race, or class and it shall not be lawful for the University to impose on any person, any test whatsoever of religious belief or profession in order to entitle him to be appointed as a teacher of the University or to hold any other office therein or to be admitted as a student in the University or to graduate thereat or to enjoy or exercise any privilege thereof;

- ◆ It may make special provisions for the employment or admission of women, persons with disabilities or of persons belonging to the weaker sections of the society, and, in particular, of the Scheduled Caste, the Scheduled Tribe and the other socially and educationally backward classes of citizens. Provided further that no such special provision shall be made on the ground of domicile;
- ◆ It shall be the endeavour of the University to maintain an all-India character and high standards of teaching and research, and the University shall, among other measures which may be necessary for the said purpose, take, in particular, the following measures:
- ◆ Admission of students shall be made on all-India basis strictly on merit adjudged either through Common Entrance Tests conducted individually by the University or in combination with other Universities, or on the basis of marks obtained in the qualifying examination in such courses where the intake of students is small;
- ◆ Recruitment of faculty shall be made on all-India basis and Inter-university mobility of faculty, with portable pensions and protection of seniority, shall be encouraged;
- ◆ Semester system, continuous evaluation and choice-based credit system shall be introduced and the university shall enter into

agreement with other universities and academic institutions for credit transfer and joint degree programmes.

- ◆ Innovative Courses and programme of studies shall be introduced with provision for periodic review and restructuring;
- ◆ Active participation of students shall be ensured in all academic activities of the university including evaluation of teachers;
- ◆ Accreditation shall be obtained from the National Assessment and Accreditation Council or any other accrediting agency at the national level;
- ◆ E-governance shall be introduced with an effective management information system;

## LOCATION OF THE UNIVERSITY

### Headquarters of the University:

The Headquarter of the University is located in Dharamshala, District Kangra, Himachal Pradesh. Dharamshala is a place with profile and is known worldwide. Serene location, pleasant climatic condition, spiritual atmosphere of the location provides an attractive ambience conducive to academic pursuits.

### Permanent Campuses:

It has been decided at the highest level that the University will have twin campuses:

- ◆ **Beas Campus** which shall be located in Dehra and will have bulk of the infrastructure accommodating about 70 percent of the academic activities and infrastructure.

- ◆ **Dhauladhar Campus** which shall be located in Dharamshala and will house about 30 percent of the academic activities and infrastructure.

**Temporary Campus:**

- ◆ **Camp Office:** The Camp Office of the University is presently located in the Sanskriti Sadan (Writers' Home) at Dharamshala (Near International Cricket Stadium).
- ◆ **Temporary Academic Block (TAB):** The Temporary Academic Block of the University

is located in a newly constructed College Building at Shahpur, District Kangra. Purpose-built, it is an eye-catching spacious three-storeyed building located amidst picturesque surroundings. Adequate to cater the present needs of classrooms, labs, faculty and students, it may provide inspiring space for academics. Large open space surrounding the building could provide facilities for outdoor games and sports facilities.

## THE VISITOR OF THE UNIVERSITY



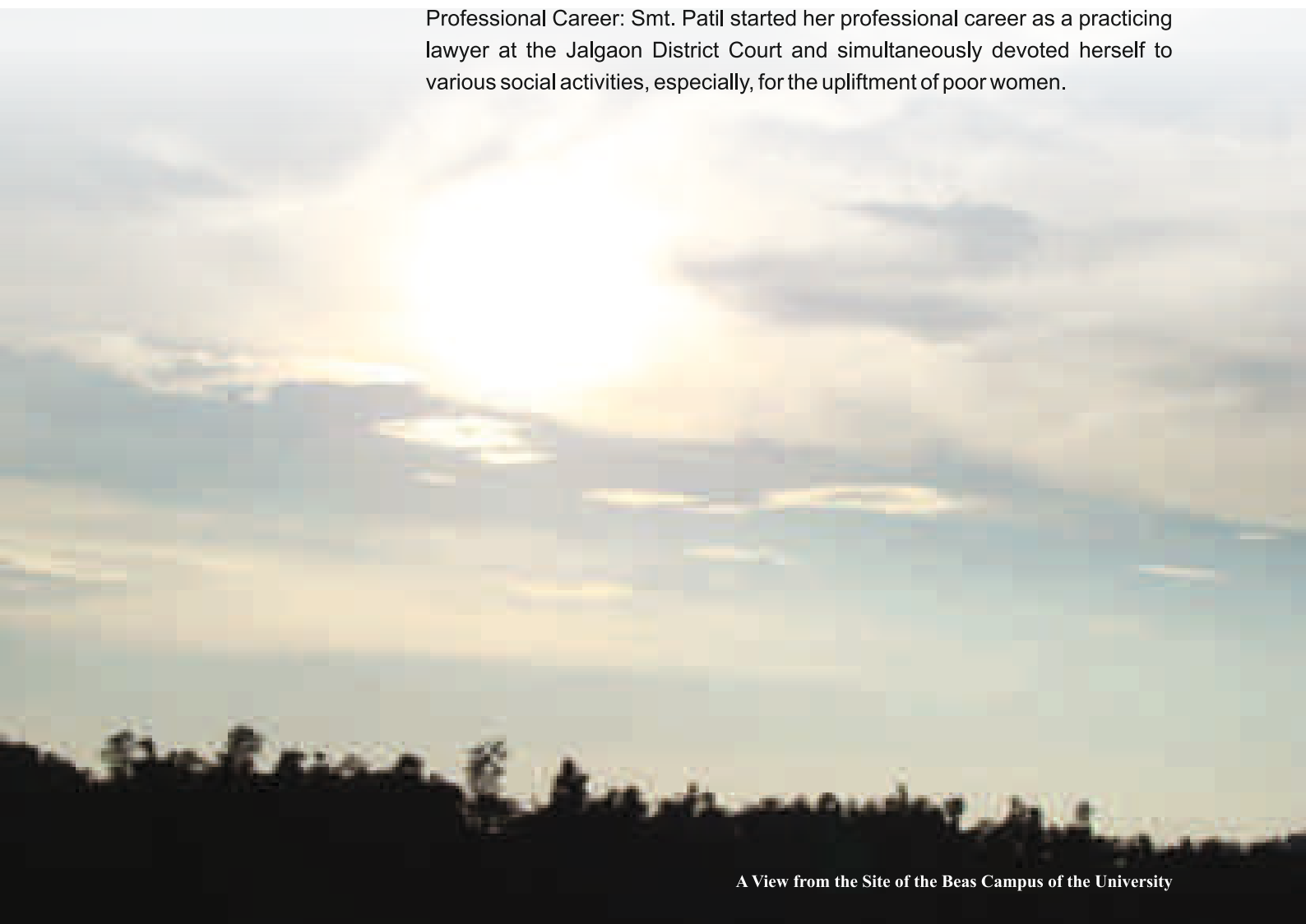
**President of India**  
Smt. Pratibha Devisingh Patil

As per the Central Universities Act 2009, the President of India is the Visitor of the University.

Smt. Pratibha Devisingh Patil was born on December 19, 1934 in Nadgaon village of Jalgaon District, Maharashtra. Smt. Patil assumed office as the 12th President of India on July 25, 2007. She is the first woman to have been elected to this august office. Immediately prior to election as the President of India, Smt. Patil was the Governor of Rajasthan from November 8, 2004 till June 21, 2007.

**Education:** Smt. Patil received her early education from RR Vidyalaya, Jalgaon and later obtained her Master's degree in Political Science and Economics from the Mooljee Jetha College, Jalgaon. Later, she obtained the degree of Bachelor of Laws (LL.B.) from Government Law College, Bombay (Mumbai). While in college, she took active part in sports, excelled in table tennis and won several shields at various Inter-collegiate tournaments. Even as an MLA, she pursued her studies as a law student.

**Professional Career:** Smt. Patil started her professional career as a practicing lawyer at the Jalgaon District Court and simultaneously devoted herself to various social activities, especially, for the upliftment of poor women.

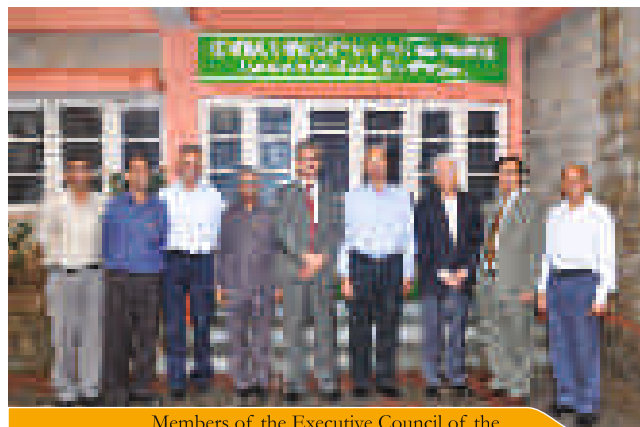

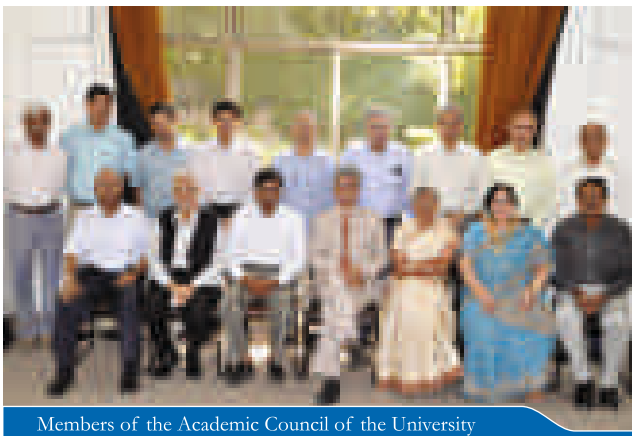

## MAJOR DEVELOPMENTAL ACTIVITIES DURING THE YEAR

### IDENTIFICATION OF LAND FOR THE CAMPUSES OF THE UNIVERSITY:

The Central Site Selection Committee comprising Prof. D.P. Singh (Vice Chancellor, BHU), Shri Sunil Kumar (Additional Secretary, MHRD), Dr. Renu Batra (Joint Secretary, UGC) and Professor Furqan Qamar (Vice Chancellor, CUHP), inspected the land proposed by the State Government. Recommendations of Committee have already been accepted by the Government of India and the sites for the campuses of the University have already been identified.

Accordingly, the MHRD vide letter No.F.42-24/2009-Desk (U), dated 23rd April, 2010, "approved the establishment of Central University of Himachal Pradesh with its headquarters and temporary campus at Dharamshala and two distinct campuses on the sites offered by the Government of Himachal Pradesh in Dehra and Dharmashala in Kangra District. While the main campus of the University will be located at Dehra, the other campus at Dharmashala will have such of the Schools/ Departments which do not require massive infrastructure as recommended by the Committee. The State Government would ensure immediate handing over of the lands, free of any encumbrances, for the two campuses simultaneously after obtaining all approvals/ clearances from environmental angle. The temporary campus of the University would be started at Dharamshala from the building of the Regional Centre of Himachal Pradesh University (Law College) under construction or other suitable accommodation to be identified by the State Government in consultation with the Vice-Chancellor" and the State Government was requested to take immediate necessary action accordingly.

During the year, steps were taken for preparation of papers by the District Administration for the diversion and transfer of land to the Central University of Himachal Pradesh.

### PROGRESS WITH REGARD TO THE TRANSFER OF LAND AND FCA CLEARANCE

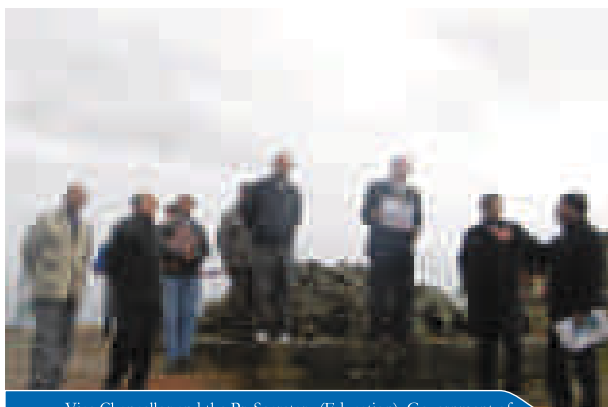
The State Government of Himachal Pradesh has allotted 62-54-26 hectares of land at Dharamshala and 317-97-97 hectares of land at Dehra for the establishment of two campuses of the University.

The issues relating to the transfer of land were taken up with the State Government and were sorted out. The papers required for getting the clearance under the Forest Conservation Act (FCA clearance) were prepared and the Master Plan is also likely to be finalized very soon.

The Revenue Department has completed necessary paper work/documentation for the transfer of land for both the campuses. Boundary Pillars on the land allotted for Dharamshala site have already been got erected through the state PWD. As regards boundary pillars for the Dehra site, the matter is being pursued with the District administration. The Forest Department has completed the enumeration of trees and identification of land for compensatory afforestation for both the campuses. In order to facilitate and expedite the work, the University has engaged the services of a Consultant and had given sanction for the expenditure to be incurred on the enumeration of trees and preparation of proposals/documents for FCA clearance. Since the proposal for FCA clearance also required the Site Plan, Master Plan and geo-technical investigation and contour survey etc, the University has engaged EdCIL India Limited as consultant and the work has been completed.

The major bottleneck as to who shall sign the proposal for FCA clearance as the User Agency and consequently bear the expenses (amounting to approximately Rs. 60 Crores) with regard to FCA clearance (NPV of trees and cost of compensatory afforestation) have also been sorted out with the State Government. A few other critical issues regarding the land such as ensuring contiguity of land and ensuring that the land transferred is free

from any encumbrance have also been taken up with the State Government and are likely to be resolved shortly.

In view of the above, it is hoped that the Proposal for FCA Clearance, a pre-requisite for the transfer of land to the University for both the campuses, is likely to be done shortly. Hopeful that the FCA clearance would be received and the land would effectually be transferred, the University is proposing to appoint Project Management Consultant (PMC) and, thus, be ready with Plans for construction and development of the permanent campuses.

### PROVIDING AND FIXING BOUNDARY PILLARS

The land so allotted was got demarcated from the Revenue and Forest Department authorities and cemented boundary pillars have been provided around the boundary of land at Dharamshala while

the said work in respect of Dehra site is to be taken up later.

### IDENTIFICATION OF EdCIL FOR UNDERTAKING GEO TECHNICAL SURVEY AND MASTER PLAN

The proposal for the FCA clearance required the University to submit its Master Plan for the two campuses. In order to get the Master Plan of the University prepared, the work regarding survey of the identified sites, geotechnical investigation, mapping of the vegetation and contour survey etc, zoning of the campuses and preparation of the Master Plan was assigned to the EdCIL India Limited, a Govt. of India undertaking. The Master Plan of the University is likely to be ready soon.

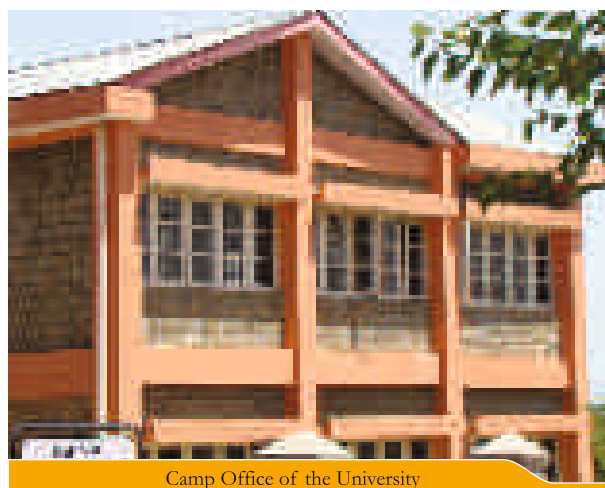
### IDENTIFICATION OF RITES AS PROJECT MANAGEMENT CONSULTANT

The RITES Ltd. have been identified as the Project Management Consultants with Architect to be appointed by the RITES with University approval. The actual construction and development work of the University shall however be commenced only after the land has been transferred to the University after obtaining necessary Environmental and Forest Clearance.

### PROGRESS WITH RESPECT TO TEMPORARY CAMPUS:

#### Camp Office of the University at Dharamshala:

Sanskriti Sadan, (Writers' Home) belonging to the Department of Art & Culture of the Government of Himachal Pradesh, was allotted, on rent basis, by the State Government to the Central University of Himachal Pradesh for the residence-cum-office of the Vice-Chancellor. As no other building could be made available for setting up office of the university in Dharamshala, the University has set up its camp office in this building.

The University has developed a fully functional Camp Office in Dharamshala, District Kangra in the building temporarily allotted by the State Government. The Camp Office is fully functional with modular furniture and has such facilities as office of the Vice Chancellor, four chambers for senior officers of the University, fully-equipped Board Room for meetings etc, eight cubicles for office staff, store room, pantry and reception, 24 lines EPBAX, Multimedia Projector, Photocopier, 17 PCs, 10 MBPS Network connectivity with Local Area Network (LAN) and Wifi.

### Temporary Academic Block at Shahpur:

An institutional building (a new government college building at Shahpur, near Dharamshala) was allotted by the State Government for establishing temporary campus of the University. The notification in this regard was received and the University took over possession during the year. District Administration arranged for the water supply and electricity to the campus on priority

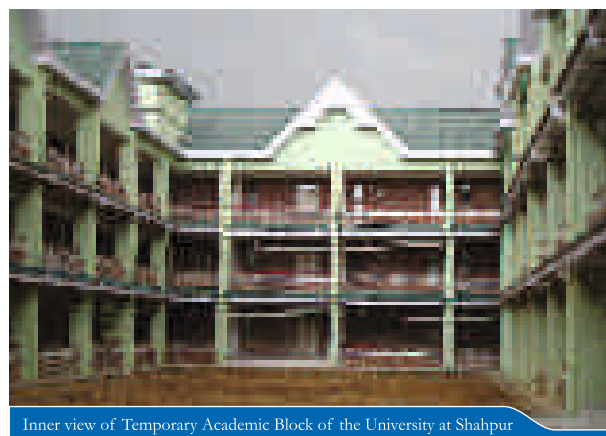


Hon'ble Chief Minister of the Himachal Pradesh inaugurates the building that was allotted to the University for the Temporary Academic Block of the University

basis. Though located at a distance of 30 Kms or about 45 minutes from Dharamshala, the building is adequate and suitable for the programmes of studies proposed to be started from the academic session 2010-11. The University has setup a fully furnished teaching block at Shahpur District Kangra (approximately 30 Kms from the Camp Office of the University) in a newly constructed Government College Building temporarily allotted by the State Government. With a built-up area of over 80000 sq ft, the Temporary Academic Block has been furnished with modular furniture and has the following facilities:

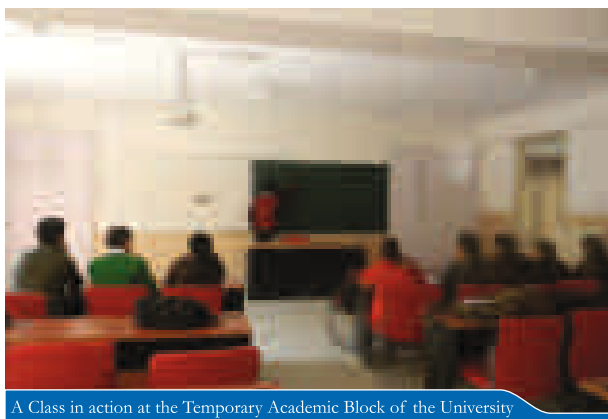

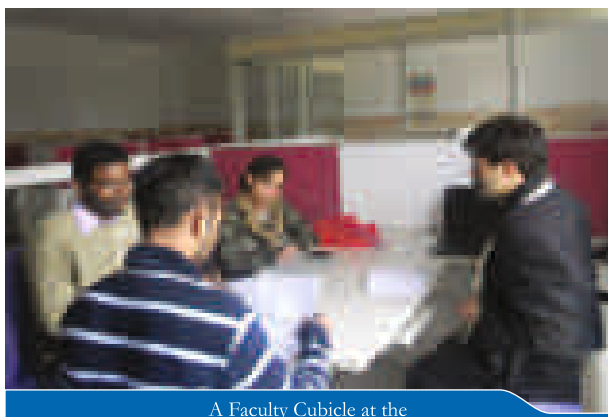

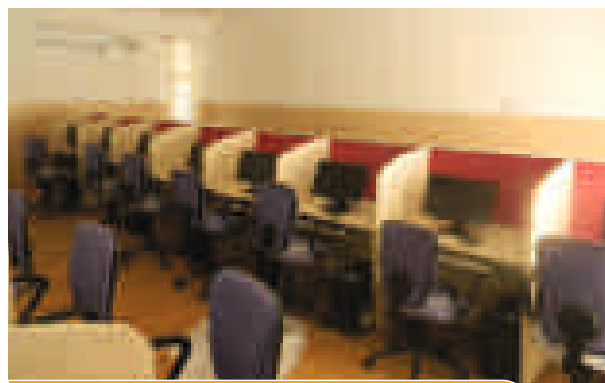


A Faculty Cubicle at the Temporary Academic Block of the University

### Temporary Residential Buildings:

The University will have to take on rent/hire/lease on short-term basis buildings for the residence of faculty, students and staff, including those for the statutory officers. The process for inviting Expression of Interest is to commence soon.

- ◆ Temporary Residence of the Vice-Chancellor: a residential building hired on rent as assessed by the state PWD and has been functionally furnished for the residence of the Vice-Chancellor.
- ◆ Temporary Hostels for Boys and Girls: The University had issued Expression of Interest for taking suitable buildings on rent to be used as hostels for boys and girls students of the University; the University is in the process of finalising the same.

- v. Statutes 42 regarding Appointment of Dean of Students' Welfare as an Officer of the University

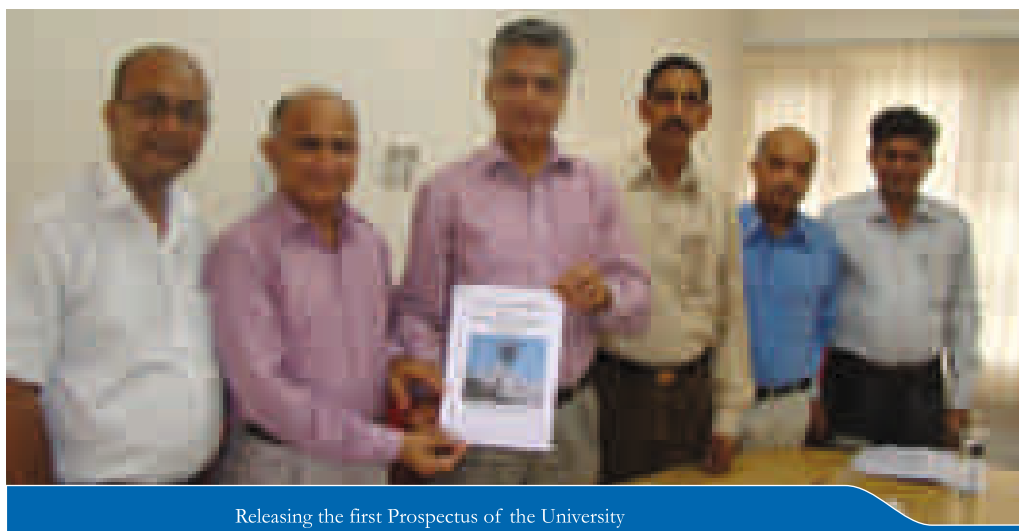
### PREPARATION OF ORDINANCES

### ADMISSION BASED ON SINGLE COMMON ENTRANCE TEST

The University has introduced aptitude-based common entrance examination for admission in all its Programmes of Studies. Candidates seeking admission in the University are required to fill up only a single admission form indicating their preference of Programmes of Studies and are required to take only one entrance examination. Accordingly, the University has introduced:

- a. **HEAT (Higher Education Aptitude Test)** as a single common entrance test for admission in undergraduate programmes across all disciplines;
- b. **FEAT (Further Education Aptitude Test)** as a single common entrance test for admission in postgraduate programmes across all disciplines;
- c. **TREAT (The Research Entrance Aptitude Test)** as a single common entrance test for admission to MPhil/PhD programmes across all disciplines;

### INNOVATIVE PROGRAMMES & CURRICULAR FRAMEWORK

Guided by the reforms agenda in higher education and learning from the experiences of the best universities of the world, the University has introduced a number of innovations, as detailed below:

**Semester-based Academic Calendar** in all academic programmes of the University –

Undergraduate (UG), Post Graduate (PG) and MPhil/PhD i.e. Research Degrees (RD) - are based on semester system, designed at par with global practices in terms of effective number of teaching days and teaching-learning inputs.

**Programmes based on Comprehensive Choice Based Credit System:** The University has introduced Comprehensive Choice Based Credit System (CCBCS) largely on the lines of the best universities of the world.

**Programmes of Studies are defined in terms of Credits:** As opposed to papers/courses in the conventional system), a student is required to accumulate:

- a. 120 UG Credits to earn a UG degree
- b. 80 PG Credits to earn a PG degree
- c. 60 RD Credits to earn an MPhil degree
- d. 120 RD Credits to earn a PhD degree.

**Students Mobility and Credit Transfer:** The University has designed a framework to facilitate credit accumulation by its students from other recognised universities of India and abroad. The university has developed a structured mechanism to work out the equivalence and accept the transfer of credits earned by its students from other universities as per the relevant Ordinance of the Central University of Himachal Pradesh.

**Students to accumulate required number of credits from across disciplines:** The interdisciplinary approach in the selection of courses is followed with 70 per cent courses from the department and 30 per cent from other



schools/departments of the university. In case of School of Business and Management Sciences, students would offer 30 percent courses University wide; 40 percent School wide and 30 percent department wide.

**Innovative approach in designing Programmes of Studies:** Department of Studies would not design Programmes of Studies as such. Instead, they would just (a) design and offer courses, based on the expertise and specialisation of their faculty members; (b) specify pre-requisite and co-requisites for each course offered; and (c) guide the students to make their own basket of courses to accumulate the required credits to complete their Programme of Studies. Thus, the focus is on 'learner-centred approach (as opposed to the conventional 'teacher-centred approach') to accommodate learner's needs and expectations to have wider choices in content, mode and pace of learning.

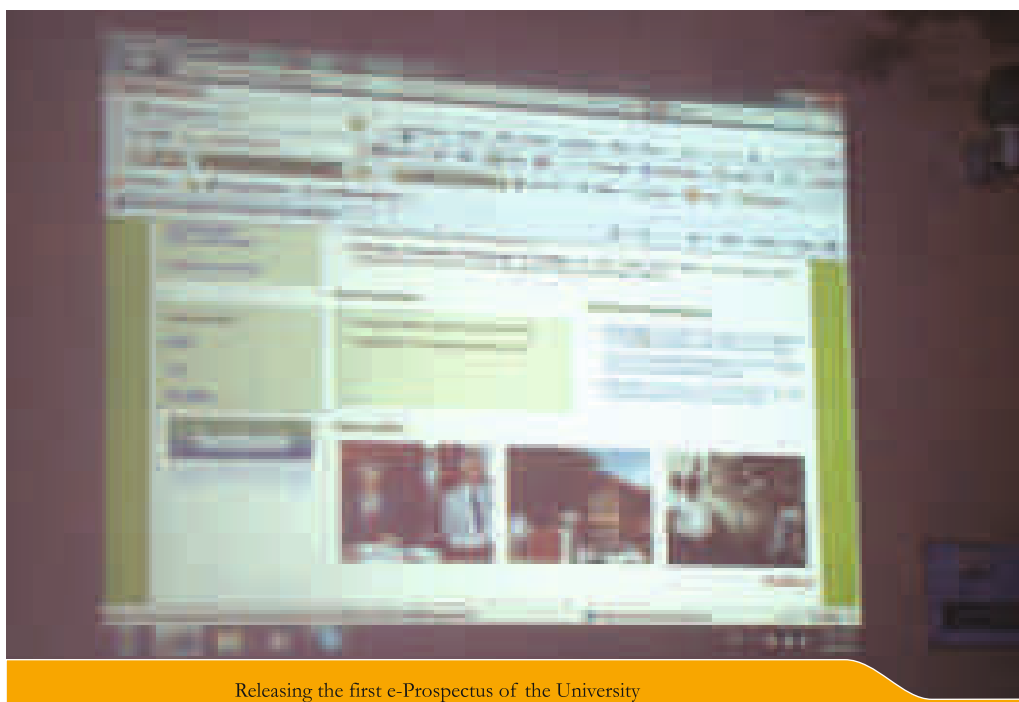
**Computation of Credits based on a Holistic Approach to Learning:** In the Central University of Himachal Pradesh, one credit is defined as equivalent to the Total Student's Efforts (TSE) of 30 Hours comprising: (a) 10 hours of lectures/organised classroom activity/contact hours; (b) 5 hours of laboratory work/ practical/field work/tutorials/teacher-led activities; and (c) 15 hours of other workload such as independent individual/ group work; obligatory/ optional work placement; literature survey/ library work; data

collection/ field work; writing of papers/projects/dissertation/thesis; seminars, etc. Thus, the focus is on in-depth learning driven by intrinsic curiosity and mastery of the subject by balancing the taught content with independently self-directed learning.

**All Programmes of Studies to be Modular:** All Programmes of Studies in the university are designed as modular with exit and lateral entry option. While most students may want to complete their UG/PG/RD without any break, some may opt out of the Programme of Studies mid way due to their own personal compelling reasons. The University, therefore, provides a structured framework for students to opt out mid-programme, whereby, depending on the extent of time spent on campus and credits accumulated by them, they will be awarded certificate/diploma/advanced diploma. For instance, if any student wants to quit studies after two semesters, he/she can do so and would be awarded an appropriate Certificate/ Diploma/ Advanced Diploma and can rejoin his/her studies from this point within two years again. Thus:

**A student admitted to UG Programme may get:**

- Certificate (if opts out after 2 Semesters with 40 UG Credits);
- Diploma (if opts out after 4 Semesters with 80 UG Credits); or
- Bachelor's Degree (if stays on to complete full 6 semesters with 120 UG Credits).

**A student admitted to PG Programme may be conferred:**

- a. Advanced Diploma (if opts out after 2 semesters with 40 PG credits); or
- b. Master Degree (if stays on for full 4 semesters with 80 PG credits).

Those who, thus opt out, would be eligible to join laterally to complete and earn their degree, if they return to the university within the next two years.

**All Programmes of Studies to be Multi-disciplinary/Inter-disciplinary:** While Departments of Studies of the University are designed around basic disciplines (to enable faculty members to continue to focus on their specialised areas of research) each Programme of Studies of the university is multi-disciplinary as the student is empowered to accumulate required number of credits from a wide variety of courses offered though out the university (e.g. a student will be entitled to learn mathematics with music, physics with philosophy, technical courses with humanities and so on). Accordingly:

- a. At PG level, a student would be required to accumulate:
  - 70% Credits through Department wide courses
  - 30% Credits through University wide courses
- b. In case of PG Programmes offered by the School of Business and Management Sciences, a student would be required to accumulate:
  - 30% Credits through Department wide courses
  - 40% Credits through School wide courses,
  - 30% Credits through University wide courses

**All Programmes to be based on Comprehensive Continuous Internal Assessment:** Students in all Programmes of Studies across disciplines and at all levels shall be assessed through comprehensive continuous internal assessment based on quizzes, assignments, independent works, group works, mid-terms and end-semester examination. As a general principle, the Comprehensive Continuous Internal Assessment shall comprise the following components:

**All Programmes of Studies to have Grading System:** The University shall have grading system based on Six (6) point scale of evaluation of the performances of students in terms of marks, grade points, letter grade and class. The total performance of a student within a semester and continuous performance from the second semester onwards shall be indicated by the (a) Grade Point Average (GPA); (b) Weighted Average Marks (WAM); (c) Cumulative Grade Point Average (CGPA); and (d) Overall Weighted Percentage Marks (OWPM).

**Innovative Research Degree Programmes:** The University has rigorous full time Research Degree (RD) Programmes that aim at honing the research skills, grooming teaching abilities, producing quality research publications and proactive participation in seminars and conferences. Accordingly, the award of RD requires a student to accumulate credits through course work, teaching assistantship, published work and dissertation/thesis. The duration and credit requirements for MPhil and PhD Programmes are as under:

- a) **For MPhil:** For successful completion of the RD Programme leading to the award of the MPhil degree, a student shall be required to accumulate a total of 60 RD Credits as under:
  - i) Course Work: 20 Credits
  - ii) Dissertation: 20 Credits
  - iii) Publications: 10 Credits
  - iv) Teaching Assistantships: 10 Credits
- b) **For PhD:** For successful completion of the RD Programme leading to the award of the PhD degree, a student shall be required to accumulate a total of 120 RD Credits as under:
  - i) Course Work: 20 Credits
  - ii) Dissertation: 60 Credits
  - iii) Publications: 20 Credits
  - iv) Teaching Assistantships: 20 Credits
- c) A candidate admitted to the Research Degree (RD) Programme is required to complete the prescribed course work in the first two Semesters of his/her admission. Notwithstanding the maximum prescribed duration of the Research Degree Programme, if a candidate fails to complete the prescribed course work in two semesters, his/her admission shall be cancelled and his/her name shall be removed from the rolls of the University. Provided further that no candidate admitted to the Research

Degree Programme shall be permitted to proceed with the Dissertation work till such time he/she completes the prescribed course work.

- d) Immediately upon the completion of formalities for admission in the Research Degree Programme, each candidate is required to submit in writing, on the prescribed format, as to whether he/she wishes to pursue for the MPhil or the PhD Degree.
- e) In case a candidate admitted to the Research Degree Programme holds MPhil degree from this University or other Universities, the Credit requirements for course work, publication and teaching assistantship may be adjusted accordingly. Such candidates will, however, be required to complete the full 60 RD Credits for dissertation work along with the balance of the credits for the course work, publication work and teaching assistantship.
- f) Computation of Credits for Publication Work: Computation of Credits for Published Work for MPhil and PhD degree is to be made as under:
  - i) 2 credits for each popular article published/ paper presented in national seminars/ conferences/ workshops

- ii) 4 credits for each paper presented in international seminars/ conferences/ workshops
  - iii) 5 credits for each Paper in approved refereed national journal
  - iv) 10 credits for each Paper in approved refereed international journal
  - v) Each Department/Centre registering candidates for RD Programme shall be required to maintain an updated list of approved journals for publication
- g) **Computation of Credits for Teaching Assistantships:** Computation of credits for Teaching Assistantships for the MPhil and PhD degree is to be made as under:
- i) 10 credits for Independent Teaching of a one-semester course of two credits;
  - ii) 5 credits for working for shared teaching of a one-semester course of two credits;
  - iii) 1 credit for every 3 Hours of involvement in assessment, evaluation, examination, course development, development of reading lists etc. (supervisor concerned to audit the workload claimed under this category and certify)

Against the 180 seats in PG programme, a total of 1741 candidates applied out of which 140 were admitted. For Research Degree Programme the University received more than 450 application for the 80 advertised seats, which were later restricted to 56 seats keeping in view the availability of faculty.

The positions of first Registrar and first Finance Officer were advertised, interviews held and selections were made. Since then these positions have been filled up. Besides three Professors were appointed on deputation who have been designated as the Deans of the Schools.

### TEACHING FACULTY

48 faculty positions were created with the approval of the Academic Council and Executive Council and with the concurrence of the University Grants Commission. Besides making appointments of four Professors on deputation, 13 faculty members were appointed on contract basis. All the created posts have since been advertised.

### ACADEMIC AND NON-TEACHING STAFF

51 positions of academic and non-teaching were created with the approval of the Academic Council and Executive Council and concurrence of the University Grants Commission, besides the Registrar, Finance Officer and Controller of Examination, which are the statutory positions. Besides making appointments of first Registrar and Finance Officer, 11 non-teaching appointments were made on deputation and short term contract basis. All the created posts were advertised.

### OUTSOURCING OF SERVICES

The University Grants Commission approved up to 50 persons for support service through outsourcing against which 35 persons were engaged during the year.

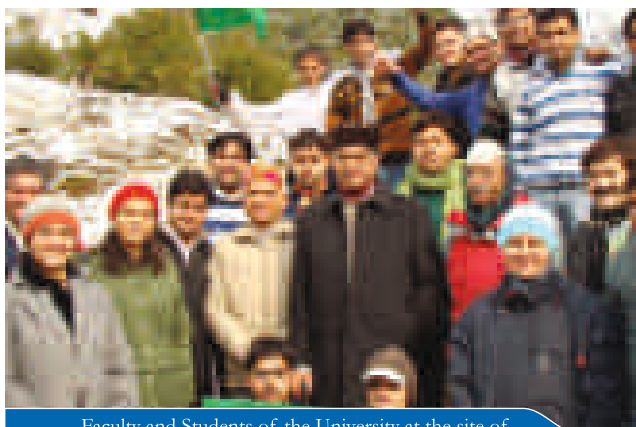

## UNIVERSITY FINANCE

### BUDGET ESTIMATES FOR THE YEARS 2009-10, 2010-11 AND 2011-12

The Budget Estimates for the years 2009-10, 2010-11 and 2011-12 were prepared and approved by the authorities of the University. The year 2010-11 started with unspent balance of the previous year amounting to ₹292.55 lakh and a sum of ₹15 crores was provided by the University Grants Commission as Development Grant during the year. The Revised Budget Estimates for the year 2010-11 and Budget Estimates for the year 2011-12, showing the grants, university income and expenditure were as under:
