ITEM NO.: 29.2

To place before the Executive Council the matter regarding grant of Study Leave to Dr. Ankit Tandon, Assistant Professor, Department of Environment Science.

Dr. Ankit Tandon, Assistant Professor has been selected for Post-Doctoral Research position starting from **01.09.2017 to 28.02.2018** (Total Six Months), with the members of research group of Dr. Markus Petters, Associate Professor at **North Carolina State University, USA** and requested for grant of study leave to him from 01.09.2017 to 28.02.2018 for the above purpose. The Teacher has informed that the North Carolina State University, USA will not be providing any Financial Assistance for his journey, stay, lodging, boarding etc. for the research work and the teacher will bear all the expenses from his own funds; the university shall not have any financial liability (other than pay) for this.

The provision of grant of study leave to university teacher is contained under Clause 14 of Ordinance No. 15 of the University which is reproduced as under:

- i. A permanent teacher may be granted study leave after a minimum of 3 years of continuous service in the University, to pursue a special line of study or research directly related to his/her work in the University or to make a special study of the various aspects of university organization and methods of education.
- ii. Study Leave shall be granted by the Executive Council on the recommendations of the concerned Head of the Department. The leave shall not be granted for more than three years in one spell, save in very exceptional cases in which the Executive Council is satisfied that such extension is unavoidable on academic grounds and necessary in the interest of the university.





- iii. The amount of scholarship, fellowship or other financial assistance that a teacher, granted study leave, has been awarded will not preclude his/her being granted study leave with pay and allowances. However, the amount of scholarship, fellowship assistant etc. so received shall be taken into account in determining the pay and allowance on which the study leave may be granted.
- iv. Provided further that the foreign scholarship/fellowship received by such teachers would be offset against pay only if such scholarship/fellowship exceeds the amount, as determined and specified from time to time, with due regard to the cost of living for a family in the county in which the study is to be undertaken. In case of the Indian fellowship, which exceeds the salary of the teacher, the study leave shall be sanctioned without pay.

The teacher has joined university on 22.11.2012 and as such fulfils the condition (i) above. Therefore the matter is submitted to the Executive Council for kind consideration and grant of study leave from 01.09.2017 to 28.02.2018 to Dr. Ankit Tandon, Assistant Professor, Department of Environment Science to avail Post-Doctoral Research position with the members of research group of Dr. Markus Petters, Associate Professor at North Carolina State University, USA.

The Executive Council granted Study Leave to Dr. Ankit Tandon, Assistant Professor, Department of Environment Science w.e.f. 01.09.2017 to 28.02.2018 with no financial liability to the University.
