## **PROVISIONAL SIXTH ELECTION LIST (OPEN CALL)**

**Admission to M.A. Economics  
Academic Session 2020-21**

The Provisional Sixth Selection list of candidates selected for admission to **M.A. Economics** Academic Session (2020-21) is enclosed herewith. This list has been prepared on the basis of merit in qualifying exams. Every care has been taken to prepare the selection list. Mistakes, if any, are inadvertent and subject to rectification.

**1. "The OBC candidates who belong to Non Creamy layer and whose castes appear in Central list of the OBCs shall be eligible for admission under the OBC category."**

**If the Candidates selected in OBC category do not belong to Non Creamy layer they must not deposit the admission fee. As their admission will be cancelled at time of verification of documents and registration.**

2. The selected candidates have to deposit the admission fee latest by **8<sup>th</sup> December 2020** failing which the vacant seats shall be offered to the wait-listed candidates.
3. Total Fee for **M.A. Economics: Rs.5000/-**
4. Option of Paying the Admission Fee shall remain open from **7<sup>th</sup> December, 2020** to **8<sup>th</sup> December, 2020**.
5. **Link of making payment for the Admission shall be available in the Dashboard of each Applicant. This Dashboard is the same from where Registration and specific Programmes of Study was opted.**
6. All provisionally admitted/ selected students of M.A. Economics programme must email the scanned copies of the following original documents for verification latest by 8th Dec, 2020.

7. List of certificates to be emailed:

1. Mark sheets of Matriculation and 10+2
2. Graduation result (Student need to produce the final year result before 20/11/2020. In case he/she fails to do so his/her admission stands cancelled).
3. Category Certificate if applicable (OBC certificate should have not been issued later than six months).
4. Character Certificate from the last attended institution.
5. Migration Certificate (In case the student does not have migration certificate by the said date he/she can submit the same within 15 days)
6. ID Card (Aadhaar Card, Voter ID card)
7. Fees Receipt
8. Self-declaration by the student (declaration form is given in page number 3)
9. Kashmiri Migrant Certificate, if applicable.
10. Persons with Disabilities Certificate, if applicable.
11. Self-declaration by the student for intervening period/ over a gap of three years, if applicable.
12. Employers No Objection Certificate if applicable.

13. Two Passport size photographs.

14. Students are directed to email the scanned copies of the documents(preferably in single pdf file)to anujsharma57801@hpcu.ac.in with carbon copy (CC) to naikvinod00@hpcu.ac.in. The subject of the email should be "MA Economics Admission 2020-21".

**8. The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.**

9. The registration for courses in a Programme of Study shall be made on **8<sup>th</sup> December, 2020**. The regular classes shall commence from **9th December, 2020** tentatively. Any change in commencement of classes shall be intimated to all selected candidates through E-mail/University website.
