#### **Subject: Selection, Admission & Fee Submission under Open Call (Academic Session: 2020-21)**

All provisionally admitted/selected candidates for admission to **MSW (Master of Social Work) programme** under **OPEN CALL** are hereby informed/advised to appear before the Admission Committee for the **verification of their original documents** on **08.12.2020 from 10.00 AM onwards**.

Instructions regarding Verification of documents are as follow:

1. Document verification will be done through **online mode**, a **googlemeet link** for the same will be sent on the registered email accounts of the candidates.
2. The production of **final year consolidated Mark Sheet of UG is mandatory**. **In case a candidate does not produce the UG final year consolidated Mark Sheet, her/his admission shall not be considered**. In such a case, a candidate may request the concerned university to issue a provisional certificate or the confidential result.
3. If a candidate does not have any other certificate (like Migration and Character Certificate), a maximum of fifteen days time will be given after **08th December 2020** to produce the same.
4. Candidates need to submit in writing (a **Self-Declaration Form** given with this notice) that the documents being submitted are genuine and original, and hence any discrepancy detected at later stage will be subject to cancellation of the admission.
5. Candidates are directed to send the self-attested copies of their certificates as a **single attachment** at both the following email addresses: [aashimacuhp12@gmail.com](mailto:aashimacuhp12@gmail.com) and [shababahmad@hpcu.ac.in](mailto:shababahmad@hpcu.ac.in)
