#### 5. Terms & Conditions:

- 1. Sealed bids are invited for disposal of Waste Paper (used Answer sheets/old newspaper/magazines and other scrap paper) on as per where as basis. Bid should be sealed in a cover duly super scribed as Tender for disposal of WastePaper."
- 2. The bidders should quote their highest rates based upon the Terms and Conditions forming part of tender document. Order will be placed to the successful bidder (quoting highest rates of purchase) out of the eligible bidders.
- 3. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received/openedon the next workingday.
- 4. The right to accept a bid will rest with the Hon'ble Vice Chancellor CUHP, who reserve the right to reject any or all the bids without assigning any reason thereof.
- 5. The quoted rate should be valid till the material has been lift out from the Libraries.
- 6. In case, the vendor fails to comply the terms & conditions, the Libraries may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemedappropriate.
- 7. The successful bidder will be liable to complete the job of lifting the material from the Libraries at Shahpur, Dharamshalawithin a period of 7 days of getting the order. If the successful bidder does not start work in time or stops the work midway or leaves the work altogether, his EMD will be forfeited and the Libraries shall have the right to cancel theorder.
- 8. It will be responsibility of the vendor to pack the material by his own labourers and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendorhimself.

- 9. It will be responsibility of the vendor that the waste paper being lifted from the Librarieswill be used only for recycling in paper mill or in pulp industry or will be destroyed in an appropriate manner to ensure officials ecrecy.
- 10. Bidders may visit the Librarypremises and inspect the quantity, condition and type of material being sold on any working day on their Own
- 11. The weighing of the material shall be jointly witnessed by a committee constituted for the purpose and bidder or his authorized representative. All weighing shall be certified by this committee. The weighing site for this purpose will be jointly decided by the successful bidder and the Libraries.
- 12. The successful bidder shall have to deposit whole amount of the estimated cost of the materials planned to be lifted in one phase in the form of DD. The DD should be drawn in favour of the Finance Officer, CUHP, payable at Dharamshala. In case, the successful bidder does not deposit the requisite money, Earnest Money Deposit shall be forfeited and order shall becancelled. Each Page of the Tender document should be signed by the tenderer.
