SELF FINANCING SEATS FOR ADMISSION IN MBA (HPKVBS) ACADEMIC SESSION 2021-22

Subsequent to Self Financing Seats for Admission to MBA (HPKV Business School) dated 12th October 2021 on <u>cuhimachal.ac.in</u> for the Academic Session 2021-22. The first Provisional Selection list of candidates selected for admission to **MBA degree program in HPKV Business School** (Academic Session 2021-22) is enclosed herewith. This list has been prepared on the basis of merit in qualifying exams. Every care has been taken to prepare the selection list. Mistakes, if any, are inadvertent and subject to rectification.

- 1. The selected candidates will have to deposit the admission fee by 21st October 2021. The date of document verification (Physical mode in Dhauladhar Parisar II) will be on 21st October 2021.
- **2.** Total Fees semester: 50,000/
- 3. Link of making payment for the Admission shall be available in the Dashboard of each Applicant. This Dashboard is the same from where Registration and specific Programmes of Study was opted.
- **4.** Proof of Confirmation of fee submission received from SAMARTH Portal / payment gateway should be send to concerned department **Email ID: info.mgt@hpcu.ac.in**
- 5. The admitted candidate must report in person to the Chairman of the Admission Committee of the concerned Department/School (HPKV Business School, Dhauladhar Parisar II) on 21st October, 2021 for registration and verification of academic qualifications/documents. He/She must bring the following documents: (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
- i. Mark sheets of Matriculation and 10+2 and Graduation.
- ii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).
- iii. Kashmiri Migrant Certificate, if applicable.
- iv. Persons with Disabilities Certificate, if applicable.
- v. EWS Certificate, if applicable
- (b) Original Documents to be submitted:
- i. Migration Certificate
- ii. Character Certificate

- iii. Self-declaration by student for intervening period/ over a gap of three years, if applicable
- iv. Employer's no objection certificate, if applicable
- v. Two Passport size photographs.
- vi. Aadhaar Card
- **6.** The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.
- **7.** The **registration** for courses in a Programme of Study shall be made on **21st October**, **2021**. The regular classes shall commence from 21st October, 2021.
- **8.** In case the seats remain vacant, the Second Selection list will be displayed/uploaded on University Notice Board/Website.
