हिमाचल प्रदेश सरकार द्वारा जारी आदेश सं Rev (DMC) (C) 20-2/2022 - COVID 19 - IV दिनांक 31.01.2022 के अनुसार सभी यूनिवर्सिटी / कॉलेज को दिनांक 03.02.2022 से खोल दिया जायेगा उसकी अनुपालना में माननीय कुलपित महोदय द्वारा हिमाचल प्रदेश केन्द्रीय विश्वविद्यालय के अकादिमक वर्ष 2021-22 मानसून सेमेस्टर के अंत सेमेस्टर के सभी परीक्षायें 14 फरवरी से 03 मार्च 2022 के दौरान निर्धारित किये जाने का आदेश दिया है। अंत सेमेस्टर के सभी परीक्षायें ऑफलाइन मोड (Offline Mode) से COVID-19 की अनुपालना करते हुए ही आयोजित किए जायेगें।

ORDER

Taking note of the present situation of COVID-19 in the State, the undersigned in the capacity of the Chairman, State Executive Committee (SEC) in exercise of the powers conferred under section 22(2)(h) and section 24 of the Disaster Management Act 2005, hereby issue following directions for the containment of COVID-19 in the State:-

- 1. 'No Mask, No Service' policy shall remain operational in the State.
- 2. Night Curfew from 10PM to 5AM will continue in the State.
- 3. Classes from 9th to 12th are allowed to function w.e.f. 03.02.2022 in all summer closing schools including residential schools (Government/Semi-Government/Private) in Himachal Pradesh. All other classes will continue to remain closed. The School administration will ensure observance of the COVID-19 SoPs and safety protocols while conducting the classes.
- 4. Universities/Colleges/Technical Education and other higher educational institutions are also allowed to open from 03.02.2022 with strict observance of COVID-19 appropriate behavior and safety protocols.
- All Coaching Centers & Libraries are allowed to open with COVID Appropriate Behaviour and safety protocols.
- 6. All social/ religious/ academic/ sports/ entertainment/ cultural/ political and other congregations including marriages & funerals are permitted up to 50% of the capacity, subject to maximum of 100 persons in indoor built up/covered areas (whichever is lower). In open spaces/outdoor areas these gatherings are permitted up to 50% of the capacity, subject to maximum of 300 persons (whichever is lower). There shall be strict observance of COVID-19 appropriate behavior and safety protocols during these congregations/gatherings.
- 7. There shall be no restrictions of capacity and working days in the offices of Government Departments/PSUs/ local bodies/ Autonomous Bodies including H.P. Secretariat and they shall work with 100% attendance in all working days. However, persons with disability and pregnant women employees shall continue to work from home. Hon'ble High Court of Himachal Pradesh will issue separate orders to the offices under their jurisdiction.
- 8. **Gymnasiums/ Sports Complex and Clubs** are allowed to function with strict adherence to the COVID safety protocols.
- 9. The shops shall open as per their normal prescribed times.
- 10. Religious langars shall remain prohibited in all places in the State.

All the Departments and Organisations of the Government, District Magistrates, Police Officers/Officials and Local Authorities of the State are directed to ensure strict compliance with the directions of the SEC ibid along with the MHA order dated 27.01.2022 (copy enclosed).

Penal Provisions:

Any person violating these measures and not following COVID appropriate behavior will be liable to be proceeded against as per the provision of Section 51-60 of the Disaster Management Act, 2005, besides entailing legal action under Section 188 of the IPC, and other legal provisions as applicable.

This Order will come into effect immediately unless otherwise specified as above and shall remain in force till further order.
