### GENERAL INSTRUCTIONS

1. Application must be submitted through CUHP ONLINE SAMARTH PORTAL, however, candidates are also required to submit hardcopy of submitted application form with all relevant testimonials/documents to the Honorary Director, Dr. Ambedkar Centre of Excellence (DACE), Central University of Himachal Pradesh, Dhauladhar Campus-1, Dharamshala, District Kangra, HP-176215.
2. Shortlisted candidates will be intimated through Email.
3. These posts are purely on temporary on contractual / co-terminus basis with the Centre (DACE) and selected candidates has no right to claim for regularization in the University.
4. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for the interview. Where the number of applications received in response to an advertisement is large and it is not feasible or convenient to interview all the candidates. The University at its discretion, may restrict the number of candidates to a reasonable limit on the basis of qualifications, experience higher than the minimum prescribed for the post. The University, however, prefers candidate possessing higher qualifications and experience.
5. Candidates are advised to visit the University website at regular intervals for the updates.
6. The process of selection may be by a presentation/open seminar/interview or a combination of all.
7. The University shall process the applications entirely on the basis of information/documents submitted by the candidates. In case the information/documents are found to be false / incorrect by way of omission or commission, the responsibility and liability shall lie solely with the candidates.

8. Before applying for a position, applicants are advised to go through the advertisement carefully and satisfy themselves about their eligibility. No enquiry in this regard will be entertained.
9. All correspondence from the University including interview letter, if any, shall be sent only to the email address provided by the applicant in the online application form. The applicants are advised to check the website of the University regularly for updates.

11. Canvassing in any form will be treated as disqualification.
12. Incomplete applications in any respect shall be summarily rejected.
13. The University reserves the right to revise/reschedule/cancel/suspend/withdraw the recruitment process in part or full without assigning any reason. The decision of the University shall be final and no appeal in this regard shall be entertained.
14. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issuing an appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the applicant in this regard.
