1. The selected candidates have to deposit the admission fee latest by **10th November 2022 at 1:00 PM.**
2. Total Fee for M.Sc. Environment Science: **Rs. 51,000.00**
3. Option of Paying the Admission Fee shall remain open from **10th November, 2022 at 9:30 AM.**
4. **Link of making payment for the Admission shall be available in the Dashboard of each Applicant. This Dashboard is the same from where Registration and specific Programmes of Study was opted.**
5. The admitted candidate must report in person to the Chairman of the Admission Committee of the concerned Department/School on **14th November 2022** for registration and verification of academic qualifications/documents. He/She must bring the following documents:
 - (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
 - i. Marksheets of Matriculation and 10+2 and Graduation.
 - ii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).
 - iii. Kashmiri Migrant Certificate, if applicable.
 - iv. Persons with Disabilities Certificate, if applicable.
 - v. EWS Certificate, if applicable
 - (b) Original Documents to be submitted:
 - i. Migration Certificate
 - ii. Character Certificate
 - iii. Self-declaration by student for intervening period/ over a gap of three years, if applicable
 - iv. Employer's no objection certificate, if applicable

- v. Two Passport size photographs.
- vi. Aadhaar Card

6. **The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.**
7. The registration for courses in a Programme of Study shall be made on **14th November 2022**. The regular classes shall commence from **14th November 2022** tentatively. Any change in commencement of classes shall be intimated to all selected candidates through E-mail/University website.
