


**PROVISIONAL SELECTION LIST (OPEN CALL REGISTRATION)****MBA-Self Finance  
Academic Session 2022-23**

The Provisional Selection list (Against Open Call Registration) of candidates selected for admission to MBA (Academic Session 2022-23) is enclosed herewith. This list has been prepared on the basis of merit in qualifying exams. Every care has been taken to prepare the selection list. Mistakes, if any, are inadvertent and subject to rectification.

1. The selected candidates must deposit the admission fee on the same day latest by **1<sup>st</sup> December, 2022 (1.00PM)**.
2. Total Fee for **Master of Business Administration (Self-Financing seats): Rs.51, 000/**
3. Option of Paying the Admission Fee shall remain open on **30th November (9.30PM), to 1<sup>st</sup> December 2022 (1.00PM)**.
4. The link of making payment for the admission shall be available in the Dashboard of each Applicant. This Dashboard is the same from where Registration and specific Programmes of Study was opted.
5. Proof of Confirmation of fee submission received from SAMARTH Portal / payment gateway should be send to the department at Email ID: [info.mgt@hpcu.ac.in](mailto:info.mgt@hpcu.ac.in).
6. The verification of documents of admitted candidates will be done on **2<sup>nd</sup> December 2022**, for registration and verification of academic qualifications/documents. He/She must bring the following documents:
  - (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
    - i. Mark sheets of Matriculation and 10+2 and Graduation.
  - (b) Original Documents to be submitted:
    - i. Migration Certificate
    - ii. Character Certificate
    - iii. Self-declaration by student for intervening period/ over a gap of three years, if applicable
    - iv. Employer's no objection certificate, if applicable
    - v. Two Passport size photographs.
    - vi. Aadhaar Card
8. The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.
